AFFIDAVIT MARTIN ALAMISI AMIDU THE PLAINTIFF/1<sup>ST</sup> RESPONDENT HEREIN

---

I, Martin Alamisi Amidu of Plot No. 355, North Legon Residential Area, Accra, make oath and say as follows:

1. I am the Plaintiff/1<sup>st</sup> Respondent and the deponent herein and the beneficiary of the ruling and order of this Court dated 16<sup>th</sup> November 2016 to examine orally on oath the 3<sup>rd</sup> defendant/judgment debtor/applicant herein for stay of proceedings pending the determination of an application to discharge or reverse the said ruling and order.
2. I was served with the application for stay of proceedings in the Court room at 9.38 am on 24<sup>th</sup> November 2016, the day I was to examine the 3<sup>rd</sup> Defendant/Applicant in the Court, consequently aborting the examination for the day.

3. The proceedings were therefore adjourned to 1<sup>st</sup> December 2016 to enable me and the Attorney General to acquaint ourselves with the application for stay of proceedings and take whatever appropriate steps we deemed fit in the matter.
4. I have read the supporting affidavit of Alfred Agbesi Woyome, the 3<sup>rd</sup> Defendant/Applicant herein made up of main 12 paragraphs.
5. I oppose the application for stay of proceedings on the main ground that it discloses no reasonable ground or grounds for the making of an application for stay of proceedings to this Court pending the discharge or reversal of the ruling and order of this Court dated 16<sup>th</sup> November 2016 aforesaid to warrant its consideration by this Court.
6. Furthermore, the mere allegation that the 3<sup>rd</sup> Defendant/Applicant is dissatisfied with and aggrieved by the said ruling or that there had been misdirection or a series of them is not a fair, just, or special circumstance warranting an application for the grant of stay of proceeding in this action.
7. I believe that the application for stay of proceedings is only intended to subvert the order of this Court dated 16<sup>th</sup> November 2016 for the examination of the 3<sup>rd</sup> Defendant/Applicant who has since the ruling of this Court on 16<sup>th</sup> November 2016 stated in several interviews on radio, television and via electronic media that he considers himself being persecuted by the Supreme Court and that he would do everything to the last drop of his blood to prevent the Court from enforcing the order of 16<sup>th</sup> November 2016 for his examination by the Plaintiff/1<sup>st</sup> Respondent herein. (Photocopies of three online media reportage of the determination of the 3<sup>rd</sup> Defendant/Judgment Debtor/Applicant to prevent his examination are annexed herewith and marked Exhibits “MAA1” –“I disagree with Supreme Court’s ruling-Woyome”; MAA2” –“Supreme Court is persecuting me – Woyome ‘cries’”; and MAA3” – “I’ll do whatever it takes for Supreme Court to reverse decision’ – Woyome vows”).
8. The public interest that I represent as the Plaintiff/1<sup>st</sup> Respondent will suffer greater hardship and inconvenience if the request of the applicant was granted.
9. In the premises I believe that the application for stay of proceedings is frivolous, vexatious and an abuse of the process of the Court and ought to be refused.

WHEREFOR I swear to this affidavit in opposition to the 3<sup>rd</sup> Defendant/Applicant's application for stay of proceeding pending his application seeking to discharge or reverse this Court's ruling and order dated 16<sup>th</sup> November 2016.
